YOUR ITINERARY

DAY 1 ~ SUNDAY~ OCTOBER 12 USA/QUITO

Depart your home town on your way to Ecuador. Upon arrival in Quito in the evening, you will be escorted to your

elegant hotel which is located in the heart of historic "Quito Antigo" and surrounded by churches, museums and national monuments.

An official National Treasure, Patio Andaluz holds centuries of history within its walls and is a marvelous building of colonial origin, which offers every visitor an experience not unlike turning back in time. It was part of the original Solaris (original building sites) that constituted the City of San Francisco of Quito at the time it was founded. Enjoy the enchantment and comfort that this elegant boutique hotel offers, with large arches, balconies, and towering attics that gives the feeling of being in the republican era. The inviting guestrooms have hard wood floors, vaulted ceilings, original works of art and fresh picked flowers and feature colonial style headboards, armoires, Latin work desks with antique lamps, color televisions and large windows looking into the courtyard. Hotel amenities include a coffee shop, full gourmet restaurant, a Tapas wine bar, spa, gym and solarium.

Day 2 ~ Monday ~ October 13 Quito~Colonial City

Your half-day tour today will show you what Quito displays: the largest colonial town of the Americas, the first UNESCO's World Heritage Site. Enjoy the eclectic architecture ranging from the modern quarters to varied colonial facades on churches and private residences decorated and balconies built along the last five centuries. The tour includes parks like El Ejido and Alameda, the monument of Simon Bolivar, the gothic Basilica of the Heart of Jesús, Independence Square developed during the past five centuries and flanked by the Presidential and the Archbishop's palaces dated back to XVII and XIX centuries and, the Metropolitan Cathedral with excellent samples of the Spanish renaissance.

Walk along the so-called street of the seven crosses and pass by the Jesuit convent, once headquarters of the first university in the country, El Sagrario church with a unique orthodox cross layout dated back to the 17th century and the jewel of the crown, the Jesuit temple of La Compañía de Jesús, perhaps the most important monument of the baroque art in Quito. From there continue to the plaza of San Francisco, with temple and convent known to be the largest of the once Spanish colonies on the Americas which displays a rich sample of artistic and cultural heritage. Enjoy an afternoon at leisure to explore on your own.

DAY 3~TUESDAY ~ OCTOBER 14 QUITO/OTAVALO

Early this morning you will depart for South America's most famous Indian fair, the Otavalo Market, centered around 'Poncho Plaza'. Drive across the colorful valleys of Guayllabamba and Cayambe. Guayllabamba is rich in fertile soil and through effective irrigation systems has become an important producer of avocado and the local cherimoya fruit. Cayambe, traditionally dedicated to dairy cattle and manufacturing of dairy products, has recently enjoyed an important boom in rose farming. The breathtaking setting offers great photo opportunities and after two hours of traveling through the riveting Andean countryside, you will arrive at the province of Imbabura, known as the Ecuadorian Land of Lakes.



The Otavalo Craft Market is the most famous and



picturesque in South America. While the main market is on Saturday's, there's always a mini market going on, no matter what day of the week one visits. Markets are meeting places for shopping, bargaining and chatter, while people of the region exchange local produce, animals, utensils, pots and pans or textiles. For visitors, the markets offer the possibility of approaching Ecuadorians at a more intimate level as you negotiate prices of a variety of woven goods, bags, hats, flutes or simply appreciate the skillful and generous people responsible for the elegance and beauty of the clothing and handicrafts. After a busy shopping day, there is nothing better than a delicious lunch at one of the local haciendas.

On your way back to Quito, time permitting, visit Cotacachi, an Indian village which features leatherwork including bags, jackets, hats, gloves and belts, Cuicocha Crater Lake, whose wonderful scenery is dominated by mountains and moorland scenes with numerous native plants and many birds or visit the village of Peguche with traditional looms and handcrafted wind instruments where you can purchase their goods directly

from the people who make them. Overnight at the PATIO ANDALUZ. (B)

DAY 4 ~ WEDNESDAY~ OCTOBER 15

GUAYAQUIL/GALAPAGOS ISLANDS: SAN CRISTOBAL ISLAND~ INTERPRETATION CENTER

In the morning you will be escorted at the airport for your 2¹/₂ hour flight to San Cristobal. Upon arrival on the island, you will be met by your naturalist guide, and taken for a short bus ride to the pier to board your vessel, the M/Y Coral I or II. From both the sea and the shore, the Galapagos Islands seem to be a glimpse into the world as it was millions of years ago, before humans walked the Earth. From the landscapes shaped by the whims of nature, from volcanic faults to mossy overgrowths, thick jungles, and glittering, endless expanses of coast, this is perhaps the only place to experience so many of the world's untouched beauties. Due to their long history of isolation from humans, both land and sea animals remained virtually fearless and unaffected by visitors. This is the land that Charles Darwin visited as a naturalist





on board the HMS Beagle, which was bound on a long scientific survey of South America and the South Seas (1831-36). His zoological and geological discoveries during the voyage resulted in numerous important publications, and formed the basis of his theories on evolution.

For the next eight days, you will bear witness to our planet's most captivating wildlife; for example, their namesake, the 600-pound tortoises, which in the Spanish language, are called Galápagos. You'll be mesmerized by the awe-inspiring landscapes and misty volcanic peaks. The underwater world is equally enchanting. The Motor Yacht Coral II is decorated with teakwood and has a modern design. Its eleven spacious cabins are decorated with a marine motif, and all have private facilities. The dining room is artfully decorated, and the sun decks of the yacht also provide shaded areas. After expert naturalists share their knowledge of the area, you will no longer be able to view your trip as a mere visit, but as a cherished experience.



After a welcome briefing and safety drill, a delicious buffet lunch is served. the San Cristóbal Interpretation Center, located in a natural setting, where it allows visitors to obtain information that will help them understand more the natural history of the Galápagos, with a great emphasis on human history and conservation. A staircase leads to the top of Cerro

Tijeretas, from where a good portion of Northern San Cristobal is visible: Wreck Bay, Lobos Islet, Punta Carola, and the impressive Kicker Rock. Overnight aboard the M/Y CORAL I or II. (B,L,D)

DAY 5~ THURSDAY ~ OCTOBER 16 GALAPAGOS ISLANDS: SAN CRISTOBAL ISLAND~ CERRO BRUJO & PUNTA PITT

A dinghy ride along the shores of tuff-stone layers will bring you to Cerro Brujo's white coralline beach (*wet landing*). You'll visit a lagoon where seabirds like Blacknecked Stilts, Ruddy Turnstones, and Whimbrels can be seen, along with some shore birds. Highlights ashore include the Chatham (San Cristobal) Mockingbird, Chatham lava lizard; both species are endemic to this island and seen nowhere else in Galapagos. You may



also spot Yellow Warblers, Galapagos Flycatchers, and with luck, a Vermillion Flycatcher (primitive subspecies to San Cristobal).

This afternoon, disembark (*wet landing*) on the eastern tip of the island and visit Pitt Point (Punta Pitt) where you'll be met by a Sea Lion colony. The impressive view is well worth the intense hike up the volcanic tuff. In addition to the Nazca & Blue-footed boobies, this island is home to the rarer Red-footed booby – the least seen of the bunch. It's also the home of the Chatham Mockingbird, only found here on San Cristobal Island.. Overnight aboard the M/Y CORAL I or II. (B,L,D)





DAY 6 ~ FRIDAY ~ OCTOBER 17

GALAPAGOS ISLANDS: ESPANOLA ISLAND ~ PUNTA SUAREZ/GARDNER BAY

Today is devoted to Espanola Island, or Hood Island as it is otherwise known, the most southerly in the archipelago. The

morning's visit is to Punta Suarez, one of the most outstanding wildlife areas of the archipelago, with a long list of species found along its cliffs and sand or pebble beaches. In addition to five species of nesting seabirds there are the curious and bold mockingbirds, Galapagos Doves and Galapagos Hawks. Several types of reptiles, including the brilliantly-colored marine iguana and the oversized lava lizard, are unique to this island. When heavy swells are running, Punta Suarez is also the site of a spectacular blowhole, with thundering spray shooting 30 yards into the air.

In the afternoon visit Gardner Bay located on the eastern shore and featuring a magnificent beach. This beach is frequented by a transient colony of Galapagos Sea Lions,



and is a major nesting site for marine turtles. You can snorkel around the small islets nearby giving you the opportunity to see fish, turtles and on occasion you'll see a passing shark. On a trail leading to the western tip of the island, you'll pass the only nesting site in the Galapagos of the Waved Albatross; these enormous birds are adorned with a wingspan of 7to 8 feet. They nest here from April to December and represent the majority of the world's population of this species. Overnight aboard the M/Y CORAL I OR CORAL II. (B,L,D)

Day 7 ~ Saturday ~ October 18

GALAPAGOS ISLANDS: FLOREANA ISLAND ~ CORMORANT POINT/ CHAMPION ISLET/ POST OFFICE BAY

This morning you will disembark to Punta Cormorant at an olivine-crystal beach for an easy walk that includes a brackish

water lagoon where bird species like Greater Flamingos, Pintail Ducks, Common Stilts, herons, sandpipers, and others may be observed. This outing also includes a white-sand beach where sea turtles come out at night for nesting (from December to May). You will have the opportunity for snorkeling or swimming around the pangas around Champion Islet, located just offshore Floreana Island. Enjoy great Zodiac rides or snorkeling along a nice wall filled with a variety of marine wildlife like the endemic black striped salema, the blue lobster, long nose and coral hawkfish, sea horses, sea lions, and the red-lipped batfish.







Schedules, accommodations and prices are accurate at the time of writing. They are subject to change.



Following lunch and a siesta, visit Post Office Bay, which historically is the location of a wooden barrel that was placed on the island in the 18th century by the crew of a whaling ship. It has been used since this time by mariners and tourists as a post office. The idea is to carry letters or postcards to their destination by hand. Apart from being the Post Office Barrel, this site was the landing area for some of the first colonists. Near Post Office Bay, you will explore the north shore of Floreana along narrow channels teeming with life. Rays, turtles and sea lions can be seen gently swimming next to your panga. After a wet landing and a short walk up to a volcanic cone, reach the Baroness's Tower, from where the entire northern shore of the island can be seen. Learn more about the fascinating past of this island. Overnight aboard the M/Y CORAL II. (B,L,D)

GALAPAGOS ISLANDS: SANTA CRUZ ISLAND~ HIGHLAND TORTOISE RESERVE & PUNTA CARRION

Dry landing and head to the mountains of Galapagos where it is possible to admire different kind of birds, such as: Tree and ground finches, Vermillion Flycatchers, Paint-billed Crakes, Yellow Warblers, and Cattle Egrets (usually standing on the tortoises' shell). The journey to the reserve offers great opportunities to see the contrasts that the island offers in reference to the variety of ecosystems. The road goes from the coast through the agricultural zone and straight up to the dense humid forests. Often, Galapagos giant tortoises are also seen on the way, wandering through pastures in the paddocks. This spot is a birdwatchers' haven, since almost every land bird present on the island lives or migrates here.

In the afternoon, you make your way round to the north coast of Santa Cruz Island, to the eastern mouth of the Itabaca Channel. A dinghy ride takes you at the entry of the Itabaca Channel in a lagoon with turquoise water, where you can observe sharks, blue-footed boobies, and different kinds of fish.









DAY 9~ MONDAY~ OCTOBER 20

GALAPAGOS ISLANDS: GENOVESA ISLAND~ EL BARRANCO PRINCE PHILIPS STEPS & DARWIN BAY PRINCE PHILLIP'S STEPS & DARWIN BAY

Genovesa, where you spend an entire day. In the morning, you will traverse Prince Phillip's Steps. Here you can view a colony of red-footed boobies roosting in mangrove trees. At the end of the trail, you are on the side of the cliff with a majestic view of the bay as well as the sea birds flying back and forth in front of you. See red-billed tropic birds, frigatebirds, masked boobies, storm Petrels, short-eared owls, and fur seals.

In the afternoon take a short panga ride to Darwin Bay, a trail which goes past tide pools where swallow-tailed and lava gulls are seen. You then enter a forest of salt bush where colonies of great frigatebirds are nesting. To attract a mate, males flap their wings and inflate a red-balloon-like

sack in their throats. You will also have the opportunity to swim and snorkel here. Overnight aboard the M/Y CORAL II. (B,L,D)

Day 10 ~ Tuesday ~ October 21 Galapagos Islands: Rabida Island/ Bartolome Island

Disembark at Rabida Island this morning, on a red-colored beach due to the unusually high content of iron in the volcanic material. A gratifying stroll along the beach of this small island allows the observation of a large colony of sea lions, marine iguanas, mockingbirds, Yellow Warblers and several species of Darwin's finches. Very close to the beach, hidden behind a strip of green saltbush, is a salt pond where at times Greater Flamingos migrate to; these spectacular birds feed on the brine shrimp found in this saline pond. From June to November pelicans nest in the surroundings. This is a great place to snorkel from the beach, both for beginners as well as for experienced snorkelers, due to the unique combination of underwater species and submarine landscapes. During



navigation to your next destination, keep your eyes open for dolphins.

After lunch, visit Bartolome, a small, rugged island off the eastern shore of Santiago where it seems like you are walking on the moon. This young island is inhospitable to most plants and animals. Embark on a 30-minute climb to a summit of a once-active volcano for a panoramic view which includes the guardian point of Pinnacle Rock, the worn-away remnant of a cone composed of spewed ashy particles. This is a steep climb aided by a wooden staircase but the view from the top is worth the effort. Down below, the water is crystal clear, and you can swim and snorkel with schools of fish after your hike. On the other side, you will find sea turtles and white-tipped sharks close to the shore. You will have time to enjoy snorkeling and



swimming from the beach with the endemic Galapagos Penguins that frequent this cove. Overnight aboard the M/Y CORAL II. (B,L,D)



$Day\,11 \sim Wednesday \sim October\,22$

GALAPAGOS ISLANDS: SANTA CRUZ ISLAND~/BALTRA AIRPORT

Your final stop before you depart is a visit to Pit Craters, geologically speaking, were not directly formed by volcanic action. They were created as a result of the collapse or sinking of surface materials into cracks or manholes. It's a great place to spot vermilion fly catchers as you walk inside an endemic Scalesia forest. Great opportunity to observe giant tortoises.

Return to the Baltra airport for your flight to Guayaquil. Upon arrival you will be met and transferred to your hotel. There are several restaurants and bars for your dining pleasure.

Combining Swiss traditions and Ecuadorian hospitality, the Oro Verde's luxurious rooms feature numerous amenities. Enjoy the rest of your day at leisure. You might want to relax by the hotel's outdoor swimming pool or take advantage of the fitness center, Jacuzzi, and sauna facilities. There are several restaurants and bars for your dining pleasure.

DAY 12 ~THURSDAY ~OCTOBER 23 LIMA



This morning, discover Lima, Peru's ancient capital, on a guided tour. Visit the Cathedral and then continue to San Francisco Monastery, an old convent founded in the 16th century. It is known for its cloister featuring mosaic tiles from Seville, Spain, and for its catacombs, which served as Lima's cemetery through the colonial period.

Your next stop the Larco Herrera Museum founded in 1926. The museum possesses more than 45,000 pre-Columbian pieces and provides an incomparable opportunity to

discover the mysteries of the pre-Inca world. The permanent exhibition contains thousands of priceless

objects, including gold and jewelry, ceramic statuary and sculptures, metals, textiles, and a display of erotic representations of the ancient world.

The afternoon and evening are at leisure. Your hotel is located in the heart of the traditional Miraflores district, just two blocks from Parque Kennedy and surrounded by Lima's finest dining and shopping. Peruvian cuisine is delightful, and Lima has many fine restaurants. Enjoy a traditional Peruvian lunch at La Huaca Pucllana restaurant located in one of the pre-Columbian temples in this 6-hectare archaeological site. This temple was built in 400 AD and is located in the nearby suburb of Miraflores. 3000 years ago, this area was an important religious and administrative center of the Lima Culture. Today have lunch at Restaurante La Huaca Pucllana, which is a warm and cozy restaurant that offers a spectacular view of the illuminated surrounding ruins.

Day 13~Friday~ October 24 Lima/Cusco/Sacred Valley ~ Pisac Market

This morning you will begin your day with a flight to Cusco, where upon arrival you'll board your bus for your drive to Sacred Valley.

Your visit will be to the town of Pisac. A vital Inca road once snaked its way up the canyon that enters the Urubamba Valley at Pisac. The citadel, at the entrance to this gorge, now in ruins, controlled a route which connected the Inca Empire with Paucartambo, on the border of the eastern jungles. Set high above a valley floor patch worked by patterned fields and rimmed by vast terracing, the stonework and panoramas at Pisac's Inca citadel are magnificent. Terraces, water ducts and steps have been cut out of solid



rock, and in the upper sector of the ruins, the main Sun Temple is equal to anything at Machu Picchu. Above the temple lie still more ruins, mostly unexcavated, and among the higher crevices and rocky overhangs several ancient burial sites are hidden. Pisac also offers a very colorful "Market Day" every Tuesday, Thursday and Sunday, but you can pretty much find artifacts every day of the week, such as handcrafted jewelry and leather, beautiful woolens and ponchos, carpets and alpaca products. The rest of the day is at leisure to enjoy the fabulous facilities of your hotel or sight-see on your own.



Your accommodations for the next two nights will be at the majestic Inkaterra Hacienda Urubamba. The most recent addition to the Inkaterra portfolio, this outstanding contemporary hacienda-style hotel in the Sacred Valley has an ideal setting as it spans approximately 100 acres and is surrounded by imposing green mountains. All 12 rooms in the main building and 24 stand-alone luxury casitas feature breathtaking views of the valley and feature interiors inspired on the area's cultural history, with colonial furniture, authentic Inca masks and handcrafted woodwork. There's a 10-acre organic



plantation on the premises and guests are welcome to pick their own produce, such as quinoa, Urubamba giant corn, medicinal herbs and a variety of potatoes, all farmed with traditional hand tools and oxen, as done centuries ago. DAY 14~ SATURDAY~ OCTOBER 25 URUBAMBA VALLEY~ OLLANTAYTAMBO

Explore Ollantaytambo this morning, a major Inca fortress and one of the few places where the Spaniards lost a major battle during the conquest. Ollantaytambo is a massive citadel which served as both a temple and a fortress. The Inca considered Ollantaytambo a temple rather than a fortress, but after their defeat, the Spanish called it a fortress and it has been referred as such ever since. The temple area is at the top of the terracing. The stone used for these buildings was quarried from the mountainside three miles away and high above the opposite bank of the Rio Urubamba - transporting the blocks from the quarry to the site was a stupendous feat, as of yet, no one has been able to establish how it was accomplished. At lunch time, you will go to a wellknown restaurant in the area, to enjoy typical food surrounded by impressive views of the Andes.



Your afternoon is at leisure to enjoy the fabulous facilities of your hotel or sightsee on your own.

Day 15~Sunday~ October 26 Machu Picchu

Today you depart on one of South America's most scenic rail trips from Ollanta Station to the legendary "Lost City of the Incas," Machu Picchu. Your one-and-a-half-hour rail journey is filled with breathtaking sights, en route to this mountaintop sanctuary of the Incas (which was hidden from the world until 1911 when Yale archaeologist Hiram Bingham rediscovered it.) Machu Picchu straddles a high ridge, with sheer cliffs on three sides, and the Urubamba River curves around it and fills the canyon with its roar. In all directions, there are the Andean peaks covered in jungle green, a spectacular setting for these ancient ruins. There are temples, houses, terraces for growing crops that could be functional





today and even gardens and a sacrificial altar. No one knows what happened to this civilization and why this city mysteriously disappeared, adding to the allure and spirituality of this incredible World Heritage site.



Be sure to explore the orchid trail on the hotel grounds which is within a spectacular cloud forest and is considered to be a genetic bank due to its wealth of biodiversity. It is the world's largest native species orchid garden, with 372 species of native orchids. In addition,

154 bird species, 108 butterfly species, more than 200 species of trees, and a great variety of reptiles and mammals, including two spectacled bears, have been seen. The hotel offers activities that promote contact with nature and the local culture and implements projects for researching and conserving the local flora and fauna in cooperation with prestigious international institutions. Your superior room is the perfect sanctuary for simple relaxation with luxurious bedding and an inviting dining area. Decorated with local crafts and eucalyptus beams, your room includes a room heater, a colonial style wardrobe, Andean slippers crafted from recycled materials, plus a complete set of environmentally friendly toiletries, all provided for your personal comfort. DAY 16~MONDAY~ OCTOBER 27 MACHU PICCHU/CUSCO

You will have the morning free to return to Machu Picchu and continue exploring the city. As you will enter the citadel early there will be wonderful opportunities to take photographs. In the afternoon, you will be returning to Cusco via rail, which takes approximately three and a half hours. Upon

check in at your hotel, the evening is at leisure.

You will be staying at the charming Palacio del Inca Cusco, a luxury hotel close to Cusco Historic Center, the Temple of the Sun, Korikancha and less than a mile from an array of museums, markets, and restaurants. It's built over Inca foundations, with parts of the building dating back to the 16th century, when Francisco Pizarro was an occupant. It's as luxurious and beautiful as you'd expect, with a fine interior courtyard, and ample rooms that were recently renovated. Entering the lobby of this elegant hotel feels just like standing inside a museum. The hotel offers 203 comfortable and well-equipped guestrooms. Room facilities include direct-dial phone and in-room safe. Oxygen can be provided in the suites upon request to help with the effects of Cusco's high altitude.

Day 17~ Tuesday~ October 28 Cusco

This morning you will enjoy a guided tour of Cusco. Visit the impressive Colonial Cathedral in Cusco that contains over 400 paintings from the Cusqueña School, beautiful cedar wood carvings such as the choir and the Pulpit, as well as some objects made of silver. Continue to Korikancha (Sun Temple), known today as Santo Domingo Church. During the Incas period, the stones of this temple were covered with gold. Your city tour ends with your visit to the gigantic Inca fortress of Sacsayhuamán. The Incas told the Spaniards that they weren't the ones who built Sacsayhuamán, but "the giants" built it. In their mythology there were huge people living in the Cuzco area, and they carried the huge stone blocks and put them together. The city of Cuzco was built in the shape of a puma, a holy animal in



the Inca beliefs. The head of the puma was actually Sacsayhuamán. Sacsayhuamán was a massive fortress of the Incas capable of accommodating 5,000 fighters. Today the complex is in ruins, but we know from chronicles and word-of-mouth from local Quechuans that it was once bigger, higher, and it even had towers. Your afternoon is at leisure. Overnight at the PALACIO DEL INKA. (B)

THINGS YOU NEED TO KNOW ABOUT ECUADOR & THE GALAPAGOS & THE PERU

Mainland Ecuador

- Quito is located at an altitude of close to 9,000 feet and may present acclimatization problems for individuals. Many of the visits to volcanoes and the
- countryside are also at higher altitudes.
- Guayaquil is at sea level but has a high degree of humidity.

Galapagos Islands

- Participants must be able to climb in and out of vehicles and boats/pangas unassisted. Bear in mind that some landings are wet, and others are dry, so you need to be able to get in and out of the boats easily enough and proper footwear is essential.
- You should also be able to tolerate nature walks at an easy pace on uneven terrain, sometimes uphill, for three or four hours at a time. The islands are volcanic and the ground in many cases is jugged and uneven. You should have good stability as falling can cause injury.



Peru

Your visit includes considerable walking/hiking at high altitudes (over 9,000 feet at Machu Picchu and 11,150 feet in Cusco). These walks are uphill, and on uneven ground, at various sites and ancient ruins. You must be in excellent physical health to enjoy this destination to its fullest. These conditions and altitudes may pose problems to participants with particular physical issues, and you should always consult your personal physician before embarking on such an adventure.

General

- To enjoy this program to its fullest, travelers must be in good physical condition and consult with a medical professional should there be any respiratory ailments.

TRAVEL DOCUMENTS: It is the responsibility of each Traveler to obtain and carry a valid passport, visa(s), and all other documents required by applicable government regulations. When traveling domestically or internationally, the U.S. Transportation Security Administration (TSA) and U.S. Department of Homeland Security (DHS) advise that everyone carry acceptable identification in order to board a flight. Acceptable identification can be found at http://www.tsa.gov/traveler-information/acceptable-ids. The name, date of birth and gender that appears on the identification card must exactly match the same data that is listed on airline ticket(s) and booking records. You acknowledge any failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing Traveler to miss flight(s), and subsequent scheduled travel bookings on cruises and tours.

Travel documents include, without limitation, airline tickets, hotel vouchers, tour vouchers, or any other document (whether in electronic form or otherwise) used to confirm an arrangement with a service provider. Travel documents may be subject to certain conditions and/or restrictions such as, but not limited to, being non-refundable, non-date-changeable, and subject to cancellation and/or amendment fees. Travel documents cannot be transferred to another person to use. All airline tickets must be issued in the name of the passport/photo identity holder. FINAL DOCUMENTS: Electronic final documents and air e-tickets will be sent to you approximately two weeks prior to departure, provided all monies have been paid in full.

TRANSPORTATION

AIR TRANSPORTATION: Your program does not include international airfare. If you require assistance, contact Classic Escapes.

AIRLINE SEATING: We request seats together for the group wherever possible. All planes are non-smoking. We can request a seating preference on your behalf, however, requested seats cannot be guaranteed. Requests should be made in writing no later than 60 days prior to departure. Bulkhead and/or emergency row seats can only be requested at airport check-in on the day of departure. Classic Escapes cannot provide the **Comfort Seating Service** as this is available on specific flights subject to availability and commercial laws as determined by each airline and at their own discretion. Boarding passes are generally issued at the airport on the day of departure, or in some cases if you precheck yourself 24 hours prior to departure. You may inquire about seat changes during check-in at the airport, based on availability, and is at the sole discretion of airline staff.

FREQUENT FLYER MILEAGE: Check the airline's website to enquire who their partners are. Obtain frequent flyer mileage on any of these carriers. Present your frequent flyer card for all flight check-ins and keep the boarding passes until you receive a statement with the mileage credit.

TRANSFERS: Roundtrip airport transfers are included in the tour for guests arriving on group flights. If travelers make their own air arrangements, they will be subject to extra transfer fees.

FLIGHT CONFIRMATION: We strongly suggest that you reconfirm exact flight times with the carrier prior to departure. Air travelers are required to check in at least 2 hours prior to departure time for domestic flights and 3 hours for international flights and must report to the gate at least 30 minutes prior to departure time. Failure to comply may result in the loss of the seat to another passenger.

HAZARDOUS MATERIALS: Federal law prohibits passengers from bringing hazardous materials on the aircraft. Federal law forbids the carriage of hazardous materials aboard aircraft in the passenger's luggage or on the passenger's person. 
